Portland Board of Education Policy Meeting December 13, 2023

Attending: Superintendent Charles Britton. Pupil Services Administrator, Dawn Davis, Tim Lavoy, Meg Scata and Patricia Dean. Excused absence: Laurel Steinhauser.

The meeting was called to order at 1:02PM.

Policy 5211. Kindergarten Enrollment Discussion took place about the plan for enrollment for entry to Kindergarten on September 1^{st at} the November Policy Committee meeting. Dr. Britton presented the updated policy, discussed expected enrollment and the waiver process. The committee agrees that policy has a sound plan for parental requests to waive the required age of 5 (five) for entrance to kindergarten - September 1, 2024. The request can be made to the principal and a school readiness assessment will be conducted. The deadline for the request for waivers is May 1, 2024. The policy is ready for a First Reading.

Policy Committee reviewed the CABE Policy Update dated December the 8th, 2023. The policy update is extensive with recommended and mandated policies for boards to consider as we are required to enact the new legislation of 2023. The Policy Committee can expect these policies to be ready by early spring. See the meeting notes in RED. The policies are:
