Portland Board of Education BOE Regular Meeting Portland High School January 5, 2021

The Portland Board of Education held a Regular Meeting in the Portland High School Studio Room on Tuesday, January 5, 2021. Board Members in attendance via ZOOM: Chair Sharon Peters, Meg Scata, Laurel Steinhauser, Tim Lavoy, Chris Darby, David Murphy, and Lauren Christensen. Also in attendance were Superintendent of Schools, Dr. Charles Britton, Director of Curriculum, Instruction and Technology, Eric Martin, Assistant to the Superintendent for Business and Financial Affairs, Stephanie Fragola, Administrators, Student Representatives, Shawn Laverty and Justin Renk, and members of the public.

#### **Communications and Updates**

#### Communications

Dr. Britton shared a notice to Superintendents from the Commissioner of Education, Dr. Cardona, dated December 17, 2020. This article discussed new quarantine guidance. Discussion followed. Dr. Britton also shared with the Board many letters from parents and community members, in favor of reopening schools.

#### Superintendent's Report

#### School Reopening Update

The Portland Board of Education discussed the prospect of returning to in-person learning next week.

T. Lavoy stated that he would support the recommendation of the Superintendent.

**Motion:** To recommend to the full Board to support the Superintendents' Reopening Recommendation for full reopening of Pre-K to Grade 6 on January 11, 2021 and hybrid for grades 7-12 until January 25, 2021. <u>Moved</u> by T. Lavoy, <u>seconded</u> by D. Murphy. Discussion followed with many concerns. Members took into account that the COVID data is from December, concerns about the number of infections rising and reopening too soon resulting in return to hybrid or total remote learning. Contact tracing at present levels is exhausting for our nurses and administrators, lack of

information about vaccine availability, changes to the quarantine period and confusion about testing were also noted. The heightened anxiety of adult staff and absences also were noted within the teaching staff. The vote was called: In favor of the motion: T. Lavoy and D. Murphy

Opposed: S. Peters, M. Scata, C. Darby, L. Christensen, L. Steinhauser The motion failed.

The Board will have an Emergency Meeting of the Reopening Committee on Wednesday, January 6, 2021 and convene a Special Board of Education Meeting on January 7, 2021 to discuss reopening of schools.
